### Treasurer's Report -

- Approval of September 2022 Financial Reports Action Item
  - RTA shelter fees for September at the time of preparation was not received, however, DDD has since received the fees
  - City collections on ad valorum taxes are 161.81% for the amt. budgeted for September, 101.82% YTD and 96.32 % total amt. budgeted for 2022
  - Expenses –Close to anticipated. Outstanding are Landscaping invoices for the months March, April, June and September not received/processed.
  - Budget is on Schedule
- Anthony Carter responded to question by Secretary Spears regarding line 224 rent –

#### President's Report – President & CEO Davon Barbour

- Expressed his appreciation to the board/staff for a successful DDD State of Downtown Luncheon. DDD continues to receive positive feedback. Hopes to double attendance next year.
- Introduced and welcomed to the DDD Marketing & Communications Team Ashley Mills
- Positions to be filled Public Affairs Director and a Research Coordinator for the Economic Department. Commissioner Bradshaw requested the job positions be circulated to the board
- DDD is working with directly with Mayor's Office of Economic Development, NOLABA and Stirling properties to host the ICSC NOLA Small Business event on November 10, 2022. For small businesses owners across the city, if they register ahead of time admission is complimentary. Commissioner Spears will be on the panel discussing marketing. CEO Barbour responded to Commissioner Barrasso's questions re attendance and whether the event was limited to downtown at this time there are 40

registrants, for the event. As a result of the pandemic, ICSC has shifted its focus from shopping malls to small businesses in the community, the event is not limited to downtown, it is citywide

- Looking forward to bringing a research person to the economic department
- o Discussed the department's attendance at various events
- o Economic Development is currently working on a new Interior Retail Grant
- The department plans to double its business and retention visits in the next month
- In response to Commissioner Barrasso's request for stormwater infrastructure update, she was informed that the contract is with Wingate Engineers for their design services. The contract will take a month to route before being executed.

- Parade will be held on 12/3/2022. Minor change to route. Starting at Elysian Fields ending at Lafayette Square
- Chair Curtis asked that marketing and communications department notify hotels/create calendars promoting the parade and holiday events
- Deep Fried Advertising Agency will now oversee design initiatives and rebranding of DDD/DDU

### Operations:

- DDD Rangers continue a successful partnership with the Sobering Center. So far, the metrics recorded at least 30-persons
- New patrol Vets Securing America started their patrol o 10/1/22. Their presence with Pinnacle and NOPD has had an impact
- Pressure washing continue a weekly basis
- Clean Team with the Mayor's strike force continue to make an impact e.g. completion of painting poles, fixtures
- Clean team continue to respond quickly to remove graffiti. Commissioner
  Bradshaw is happy to support a creative program that will encourage the graffiti
  artists/kids to create art in a positive way. CEO Barbour informed the board the
  graffiti program continues to be promoted to property owners. DDD is looking
  into anti-graffiti coating for buildings
