Approval of February 2023 Financials - Action Item*

Internal revenues:

- Bank revenue for January received
- Interest on bond proceeds for January received
- RTA transit shelter services discontinued (DDD will no longer have that expense)
- City sources collections for February are 6.56% of the amount budgeted, 23.94% amount budgeted year to date and 0.62% total budgeted for 2023

Approval of Stormwater Escrow Transfer - Action Item*

After a review of proposals submitted by financial institutions, the staff recommended the escrow be transferred to JP Chase Morgan.

Commissioner Moses will go with the recommendation with the proviso that eventually some of the funds be placed in various institutions in town.

Commissioner Moses had two caveats:

- 1. Any fees and expenses not disclosed then the decision to go with JP Chase Morgan be returned to the Finance Committee.
- 2. Would like legal counsel to review the documents

Chair Ross moved to approve JPMorgan as escrow agent. After further discussion and concerns voiced by both Commissioner Major and Chair Curtis, Commissioner Moses amended the motion to approve the escrow transfer to JP Morgan Chase provided the funds only be invested in government back securities.

Motion to approve Commissioner Moses, second by Commissioner Major. Motion carried.

Approval of Stormwater Infrastructure Engineering Services Contract – Action Item*

Several pre-qualified engineering firms were asked to submit proposals to advise the DDD on the design and implementation of the joint City/DDD project. Because of the delays by the city in selecting an engineering firm the DDD delayed execution of the agreement with Meyer Engineering

Move to approve Commissioner Moses, seconded by Commissioner Major. Motion approved

Approval of LLA Compliance Questionnaire - Action Item*
